Call To Order

Minutes

Res. #2011/34 – Boyd / McMorris

That the minutes of the regular council meeting of February 1, 2011 be accepted, as circulated.

Carried

<u>Delegation – Jon Graham / Robert Conly – Proposed Arthur Shoreline Project</u>

Messieurs Graham and Conly were present to discuss the proposed revetment project for the area north of the Arthur stairs. Matters discussed included:

- Mr. Graham is the contractor retained by the project proponents
- Project area consists of four lots 203 to 209 Sunset Boulevard
- RMVB received preliminary report from SETC this morning
- Bank at 203 and 205 Sunset is now private land; some of the land to the west of the bank is part of the private owners' land titles

Council thanked the delegates for attending the meeting and advised that it was not prepared to make a decision as members had just received the SETC report.

<u>Delegation – Gregg Hanson – Shoreline Protection Project</u>

Mr. Hanson was present to provide Council with an update on the area property owners' proposed temporary shoreline protection project. Highlights of their presentation included:

- They are requesting permission to protect the sand banks this spring with temporary 4x4x4 foot geo-textile sandbags stacked two high.
- The sandbags would be filled with beach quality sand from a local source.
- Currently sixteen of seventeen property owners are prepared to participate in this temporary initiative.

Council thanked Mr. Hanson for his presentation and indicated that it would consult the Municipality's solicitor to discuss a possible agreement between the property owners and the Municipality that might enable the project to proceed as a temporary measure.

Delegation – Wolf Kraft – Subdivision Proposal Lot 6 SP Plan 19580

Mr. Kraft was present to discuss his subdivision proposal for land east of PR504 and north of Clearwater Cove. Highlights of the discussion included:

- Road/Subdivision Hearing completed
- Rezoning "on hold" for the time-being
- Approval for access off PR504 to be obtained by owner

Council thanked Mr. Kraft for attending the meeting and informing it of his plans.

Res. #2011/35 – Morrison / McMorris

That the R. M. of Victoria Beach council approve the proposal to subdivide Lot 6 SP Plan 19580 – Amaruk Holdings Ltd. (File #4198-10-5376) subject to the following conditions:

- 1) That the applicant enter into a development agreement with the Municipality to the extent deemed necessary by council;
- 2) That the planning area be rezoned, if necessary, to accommodate the intended use of the subject lands:
- 3) That the applicant confirm with the Municipality and Community Planning Services Beausejour a preferred means of legal access to proposed Lots 1-3 as per the recommendation from Manitoba Infrastructure and Transportation;
- 4) That variation orders be obtained, if required; and
- 5) That the applicant comply with all conditions of *Subdivision Policy #2008/1* applicable to the proposed subdivision. Carried

<u>Delegation – Nancy Danwich / Tom Aldridge – Summer Winds Family Festival 2011</u>

Ms. Danwich and Mr. Aldridge were present to apprise council of the Summer Winds Family Festival Committee's plan relating to the 2011 event. Matters discussed included:

- Proceeds to benefit proposed community facility (new sports club building)
- Two-day event / security on site
- Request for RMVB support / designation as a "community event" for MLC purposes

NOW THEREFORE BE IT RESOLVED that the RM of Victoria Beach council consider establishing a Shoreline Erosion Advisory Committee consisting of selected constituents for the purpose of advising the Council of the RM of Victoria Beach on issues revolving around shoreline protection according to the terms of reference outlined for this Advisory Committee.
