Call To Order

Minutes

Res. #2011/1 – Morrison / McMorris

That the minutes of the regular council meeting of December 20, 2010 be accepted, as circulated. Carried

<u>Delegation – Stuart Juzda – Re: Shoreline Protection Project – Alexandra & King Edward Beaches</u> Mr. Juzda was present to outline his concerns with the process followed by council relative to the proposed shoreline protection project along the Alexandra and King Edward lakefront. His concerns included:

- Mandate of council
- Allowing private owners to use public land for placement of the works
- Negative impact of the works on the beach
- Council not representing the majority of the electorate
- Proposed project is contradictory to past practice of adopting change in a conservative manner

Council thanked Mr. Juzda for attending the meeting and apprising it of his concerns.

Dave Allwright / Dennis Eirikson – Alex Anderson Sports Club Building Project

Messieurs Allwright & Eirikson were present to update council on the progress of their Club's plans to build a new facility on the north side of PTH59 at Ateah Road. A written report was provided to all council members. Highlights of their presentation included:

- Phase I completed \$300,000 (materials / labour / in-kind)
- Phase II 2011 construction heating, mechanical, curling rink, atrium, etc. \$2,100,000
- Phase III hall & fitness area \$523,000
- Phase IV large hall \$872,000
- RM financial and in-kind support advance on sale of lots at "old" site (\$350,000)
- Club & RM to lobby government officials for capital grants

Council thanked the delegates for attending the meeting and providing the update.

That By-Law No. 1530, authorizing the payment of indemnities & expenses to the Reeve and Council, be given 2nd reading.

Res. #2011/5 – Morrison / McMorris That By-Law No. 1530 be given 3rd reading and passed.

Res. #2011/6 – Morrison / McMorris That By-Law No. 1531, amending By-Law #813, being the Victoria Beach Planning Scheme 1969, as amended, be given 1st reading. Carried

Res. #2011/7– Boyd / McKibbin That the R. M. of Victoria Beach council approve the 2011 Building Inspector Contract between Russ Clifton and the Municipality and that the Reeve and CAO be authorized to sign said Contract. Carried

Res. #2011/8 – McKibbin / Boyd

Whereas the R. M. of Victoria Beach council is concerned with the potential negative impact of shoreline protection works on the environment;

And Whereas shoreline erosion appears to be occurring at a greater rate due, in part, to the changing weather patterns;

And Whereas council expects that more shoreline protection projects will be proposed as a result of the increased erosion and bank losses;

Now Therefore Be It Resolved That the R. M. of Victoria Beach council investigate the cost of conducting an environmental impact study to determine the effect of shoreline works on the environment within the Municipality. Carried

Res. #2011/9 - McKibbin / Boyd

Whereas the R. M. of Victoria Beach council is concerned with the potential negative impact of shoreline protection works on the environment;

And Whereas shoreline erosion appears to be occurring at a greater rate due, in part, to the changing weather patterns;

And Whereas council expects that more shoreline protection projects will be proposed as a result of the increased erosion and bank losses throughout the south basin of Lake Winnipeg;

Now Therefore Be It Resolved That the R. M. of Victoria Beach council propose that a Geotechnical Engineer be hired by South Basin Mayors & Reeves Inc; cost to be shared equally by all member municipalities of said Organization.

That the R. M. of Victoria Beach council approve the Municipality's continued membership on the South Basin Mayors and Reeves Committee and that the CAO be authorized to submit payment of the 2011 membership fee (\$1,000) to said Organization. Carried

Res. #2011/11 – McMorris / Morrison That the R. M. of Victoria Beach council agree to cost-share the topographical survey of the Municipality's shoreline between Alexandra and King Edward beaches; total cost to the Municipality \$2,100. Carried

That the R. M. of Victoria Beach council approve the continued membership of the Municipality in the Red River Basin Commission and that the CAO be authorized to submit payment of the 2011 membership fee (\$300) to the Commission. Carried
