OPEN SESSION - Reeve McDonald opened the floor to anyone who wanted to make comments or suggestions regarding municipal issues.

The following questions and concerns were raised by members of the audience:

- What has the RM done about the erosion caused by high Lake levels?
- RM should install signage to stay off banks along all of Sunset
- RM should have a "crow bounty"
- Too many vehicles & equipment in the Restricted Area
- RM should have a generator to operate the Water Treatment Plant during power outages
- Garbage pick-up should be more efficient
- RM should consider installing a street light along the roadway by the Moonlight Inn
- Parking Lot should have a designated area for carts
- Commercial garbage bin is too close to private property & should be moved next to the other container by the Recycling Depot / lid is very heavy & may cause injury
- Dogs running at large have any been picked-up this summer?
- VB HELP Centre is selling green civic addressing signs
- Is RM planning to remove large rocks near King Edward stairs?
- PTH59 road shoulders need to be repaired
- Will RM remove trees on its property that are leaning and dangerous?
- Less ORV traffic since the RM passed the ORV By-Law restricting usage signs should be installed at strategic locations
- Are RM minutes available on website?
- Speed limit signs at Albert Beach are mostly hidden by brush trimming required
- Too many vehicles / traffic at specific project sites

The above questions / concerns were answered by council. Additional information was provided as follows:

- RM has written to the Minister of Water Stewardship re: high Lake level / erosion
- A commitment was made to order more signs warning people to stay off the banks
- The RM has no immediate plans to purchase a generator to operate the Water Plant this item could cost \$250,000
- RM will request repair of PTH59 road shoulders to MB Highways
- RM will endeavour to remove trees on its property that are dangerous
- Minutes and other information are available for downloading on the RM website

PRESENTATION – Stan Kaczanowski made a slide presentation relating to forest fire prevention. He also commented on the Fire Smart program undertaken by the Municipality in 2005 and indicated that he was seeking council's support to implement a Community Wildfire Protection Plan for Victoria Beach.
