- N. Ramsay water already pools along the back of her property & her neighbours' properties ditching along Girard Street could be improved concerned with drainage water from proposed subdivision
- L. Perrin existing drainage / water should be directed in a westerly direction towards PTH59

Council agreed that this would be preferable but there are some concerns with damage to fibre optic cables that are buried in that area

L. Henderson – RM should consider imposing restrictions on development / building especially in the summer season
