





We have put up temporary fences on unsafe paths and along King Edward to try and stop people from climbing up and down the banks.


We have been running the large pump in Albert Beach to help with water removal as needed.


Leaks in the water lines have been repaired as needed.

We continue to do our bi-weekly water testing on both the Victoria Beach and Albert Beach water systems.


We have also been hauling sandbags to Wanasing and other areas for protection of the dike.

#### **Golf Course Report**

- The tournament scheduled for June 28<sup>th</sup> has been confirmed for at least \$700. This could increase if there are late registrations.
- Memberships to date are 160. Total memberships for last year were 254. We have attracted some new members from last year. He did not get negative comments re the fee increase.
- Twilight golf did not bring in extra revenue. We will try it again in the fall, but Karl does not think the cost/benefit warrants offering twilight golf next year.
- Karl would like PW to dump gravel at the intersection of Sam McMorris way with 8<sup>th</sup> Avenue to get rid of the puddle that accumulates at that spot every time it rains. Also, more gravel is needed on the road that runs behind the clubhouse from the gate to the shop.
- The shop yard still needs to have the refuse removed.
- Karl has spruced up the waiting area at the first tee box. He and Ramona built the archway that now spans the exit off the ninth hole. It's a great addition and people have been posing for pictures under it.
- The following new, used equipment has been purchased at below budgeted rates:
  - Top dresser @\$1000.00
  - Fertilizer spreader @500.00
  - Aerator @1500.00

Karl may have a line on a weed sprayer at an exceptionally low price.

• Trees will be planted this fall to replace some of the ones that had to be removed last year and to fill in the tree borders between the fairways.
