<u>Harold Graham – Zoning Classification of Property – 86 Saffie Road</u> Mr. Graham was present to discuss his concerns regarding the current zoning designation of his property. Highlights of the discussion included:

• Property was developed in the 1950's (dwelling existed long before 1969)

- Property was zoned "O" (non-residential) when Planning Scheme was passed in 1969
- Land should have been zoned for residential use RM should correct the error
- Error may have occurred because land was not surveyed as a separate parcel

Council thanked Mr. Graham for attending the meeting and indicated that it would consider moving ahead with rezoning his property.
